Repositories in the NRP – Terms of Service

- NRP Operator = CESNET, z.s.p.o.
- Repository Founder
 - A. Individuals
 - A repository can be established by a natural person who represents an expert group with the need for a domain-specific repository.
 - B. Individuals under the auspices of the organization
 - The organization enters into a framework agreement with the NRP operator, which allows members of the organization to apply for the establishment of a repository with institutional backing.
 - C. Organization
 - The repository is set up directly by the institutions on the basis of a contract with the NRP operator. Other partner organizations can also participate in the operation.

Repositories in the NRP – Terms of Service

- Repository Administrator role must be established
- NRP guaranteed service level = best effort
 - “The NRP Operator makes every effort to guarantee the availability and security of data services and the preservation and security of data.”
 - state-of-the-art technologies for repository operation are used
 - protection of stored data
 - access to stored data
 - hardware redundancy
 - security policies
 - hardware suppliers' support
 - hardware housed in the Czech Republic

Repositories in the NRP – Terms of Service

- NRP is intended for building repositories with long-term data storage
- Only repositories of FAIR research data can be established in the NRP
- *Repositories in the NRP ToS* is rather general; details on operating the individual repositories are expected to be covered by the repositories' policies
- Policies of the respective repositories must comply with the *Repositories in the NRP ToS* and the *Conditions for Creating New and Modifying Existing Domain Repositories*

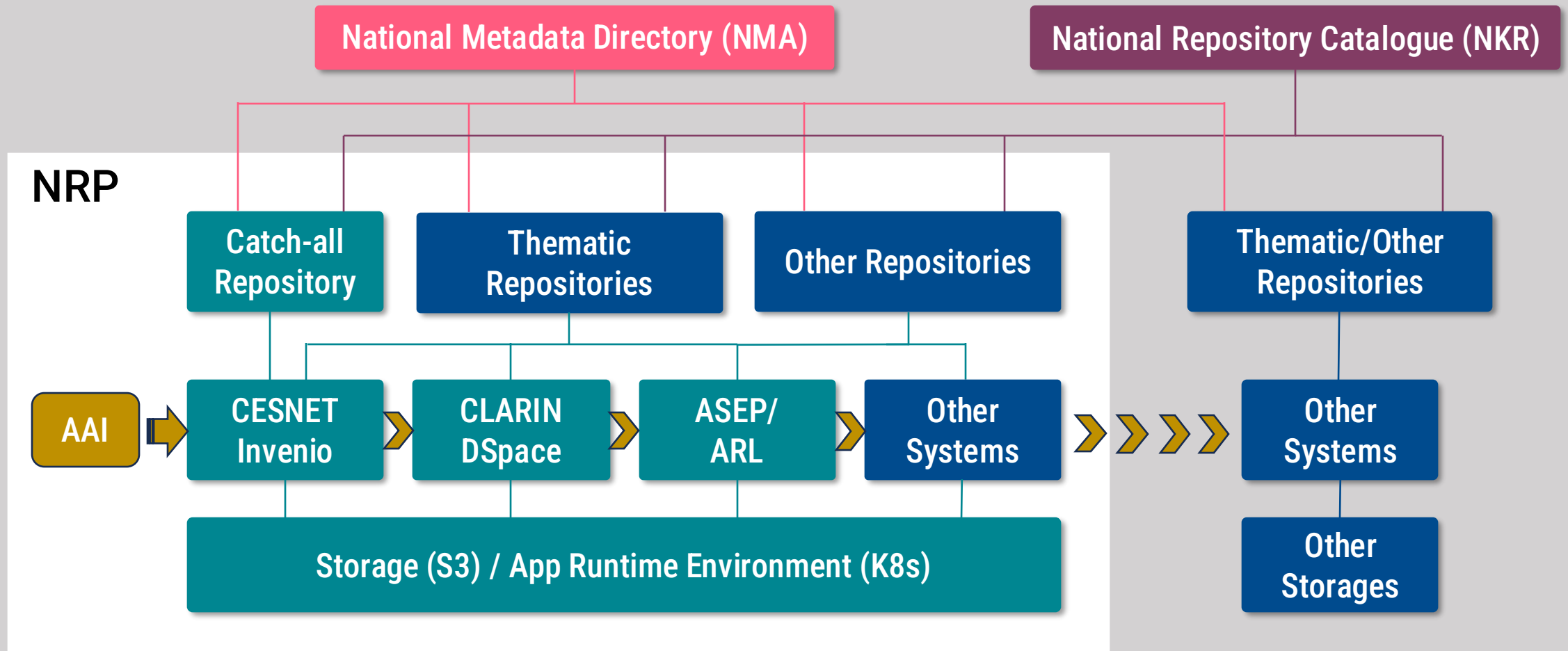
Conditions for Creating New and Modifying Existing Domain Repositories

- “A repository is the technical, personal, and procedural provision of a long-term storage for the preservation and publication of citable digital objects.”
 - digital objects = data and metadata
 - citable = clear identification (PIDs) + guarantee of immutability (policies)
 - publication = (selected) metadata always public, data as open as possible
 - long-term = specified in the repository policies
 - technical = this is what NRP takes care of
 - personal and procedural = this is what the user community primarily provides

Conditions for Creating New and Modifying Existing Domain Repositories

- Basic scenarios
 - Establishing a Repository Using the Core Repository Systems
 - Establishing a Repository Operated on NRP Resources Without Using the Core Repository Systems
 - Integration of an Existing Independently Operated Repository into the NRP/National Data Infrastructure (NDI)

National Data Infrastructure (NDI)



Roles – infrastructure

- NRP Operator (Provozovatel NRP)
 - responsible for operating the NRP as a whole
 - issues the Repository in the NRP ToS
 - contract party for the Repository Founder
- Repository System Provider (Provozovatel repozitářového systému)
 - CESNET Invenio, CLARIN DSpace, ASEP/ARL teams
 - reports to the NRP Operator
 - communicates directly with the repository system specialists
- Repository system specialists (metodici repozitářových systémů)
 - primary point of contact for everybody seeking to establish a repository
 - communicate with repo system providers and the NRP Operator
 - guide the user community through the process of establishing/integrating their repository in/to the NRP

Roles – Repository Founder

Zřizovatel

- person/organization requesting repository's establishment
 - contract party for the NRP Operator with organization-established repositories
- guarantees that repository policies are defined and published
- designates the Repository Administrator
- deals with issues escalated by the Repository Administrator and/or NRP Operator
- reports potential security breaches to the NRP Operator
- can request termination of their repository

Roles – Repository Administrator

Správce repozitáře

- must be designated by the Repository Founder
 - in repositories for individuals, the Founder is automatically the Administrator, too
- must be available throughout the entire lifecycle of the repository
- has primary responsibility for the data stored in the repository
- can restrict repository access to users
 - with compromised logon credentials
 - breaching the ToS or *Conditions*
- primary contact for the NRP Operator
 - configuration of the repository
 - operational events of the repository systems or the entire NRP (e.g. updates, outages, etc.)
- designates other roles in the repository (e.g. data curator)

Roles – Repository Administrator

Správce repozitáře

- repository configuration **using** the core repository systems
 - metadata profiles available in the repository
 - list of licences available in the data deposition process
 - deposition and data access workflows
 - roles of user groups in the repository, linking to AAI
 - user documentation for the repository
 - repository policy, especially the conditions of record immutability
 - end-user support
 - hand over records' metadata to NMA/repository config to NKR

Roles – Repository Administrator

Správce repozitáře

- repository configuration **without** using the core repository systems
 - all of the above, and the following
 - installation and operation of the repository and the appropriate sw infrastructure
 - implementing the assignment of persistent identifiers
 - technical configuration for metadata harvesting into the NMA
 - technically configuring the workflow for data deposition and data access control
 - configuring technical integrations with the NRP AAI
 - user support for end-users at all levels, from L1 to L3
 - secure logging of repository systems into the NRP's central logging system
 - operational monitoring

Deposit Licence

Depoziční licence

- every depositor/submitter
 - declares they are authorized to deposit their dataset in the repository
 - grants a licence to the repository Administrator to use the dataset, in particular the right to
 - reproduce the dataset and its content,
 - communicate it to the public,
 - store it
 - solely for the purpose of permanent storage and making the dataset available in the Repository
- NRP [deposit licence agreement templates](#) are available

User Licences

Licence pro koncové uživatele

- Czech Core Metadata Model (CCMM) requires that a licence to use the dataset (user license) is assigned to datasets in NRP repositories (**terms_of_use** attribute)
- for now, there is no NRP “license vocabulary”, i.e. every repository can have
 - its own list of recommended licenses
 - option for adding specific licenses by the submitters/depositors
- having a controlled NRP licence vocabulary has been raised as an issue at the [CCMM-controlled-vocab](#) GitHub repository
